UFCW Chemical Workers Council Scores Consecutive Organizing Wins

The International Chemical Workers Council (ICWUC) of the UFCW, last Friday, scored an organizing victory when a majority of the 20 workers at General Chemical Corporation in Midlothian, Texas, voted to join UFCW Local 3C in Grand Saline, Texas.

The victory last week at General Chemical Corporation follows two other ICWUC/UFCW recent organizing wins at Texas Gas in south Louisiana and Norit Americas, Inc., in Marshall, Texas.

The 25 workers at Texas Gas, a gas transportation company, had voted in late August to accept Local 187C in Kenton, Tenn., as their bargaining representative. A few weeks later, 15 workers at Norit Americas, Inc., the world's largest manufacturer of activated carbon, followed suit and voted to be represented by UFCW Local 130C in Waskom, Texas.

"We are very proud of our efforts to organize new members into the ICWUC/UFCW," said Frank Cyphers, President of the International Chemical Workers Union Council of the UFCW. "The recent victories are a proof that the UFCW Chemical Council is growing, not going," Cyphers added. "We are preparing to begin contract negotiations shortly and we look forward to achieving a better standard of living for our new members." **OP**

UFCW Local 328 Members Sponsor Health Care Rally in Providence, R.I.

New National Poll Shows Support for Mandate with Public Insurance Option

A new poll commissioned by Health Care for America Now (HCAN) found that 60 percent of voters do not want to be forced to buy health insurance without being given the choice of a public health insurance option to compete with private insurance.

The poll also found consistent support for employer responsibility. Sixty-one percent of voters support a requirement that all but the smallest businesses help pay for coverage.

Finally, the new poll found that voters support a surcharge on upper-income households. Sixty percent of voters favor raising taxes on households making more than \$350,000 a year in order to pay for health care reform.

Hundreds of Cincinnati and Toledo Areas Stewards Converge for Local 75 Steward Seminar on Growth

“This has been educational and informative,” said stewards Barb Imm and Mary Colling. “We picked up a lot of knowledge we didn’t really know before—tools that will help us meet and overcome our challenges. I think our stewards at former Local 911 have always been interested in sharing information, and now that we have joined with Local 1099 to be Local 75, we are sharing even more information.” **OP**
